Transition to new Property Manager

Our contract with Fleisher Property Management expired on September 1, 2017. The Board met with several companies over the summer and requested proposals from three property management companies regarding the management of our community. The Board received proposals from all three companies which were reviewed at the special meeting of the Board on August 28^{th.} Additional questions were raised by the Board and submitted to two companies. The Board is currently reviewing the responses with a final decision to be made no later than September 15th. As many of our members know, the HOA has been through three property management companies since October 2015 and the Board is carefully considering each proposal for services provided, the cost to the HOA, the core competencies each property management company brings to our community and the fit of the property management company personnel with our community. Once engaged, you will be notified and all references to our property management company on our website will be updated.

We understand that there are several deferred maintenance issues that need to be immediately addressed by our new property management company including the removal of dead trees on the easements, mowing of the fire evacuation trails, weed control, and notification of several rules and covenant violations. The Board wants to thank our members for bringing these items to our attention and will ensure that these are promptly addressed.
